t's inspiring to pause and reflect on all that the staff and volunteers accomplished at the High Desert Museum in 2022. The year brought a series of exciting moments, from celebrating our 40th anniversary and welcoming a new baby otter, to gathering for the first inperson High Desert Rendezvous fundraiser since the pandemic began–with donors giving more than \$520,000, the most successful effort in the 33-year history of the event!

This annual report to you, our members, donors and supporters, shares a glimpse of the vital work that you helped make possible. With your support, the Museum brought to life 12 rotating exhibitions, including exploring the history of intentional communities in *Imagine a World* and immersing visitors in the cold alpine environs of *Under the Snow*.

We returned to events with robust, insightful programs. Attendees marveled at Antonio Huerta's charro roping techniques, peered at the stars through telescopes during the Welcome the Night party, and imagined hiking the length of the Grand Canyon with Kevin Fedarko, author of "The Emerald Mile," as part of the Waterston Desert Writing Prize Ceremony.

And, we continued our critical initiatives behind the scenes to better serve our community. This included collaborations with Tribal partners to care for our Native American collection with a deeper understanding, sensitivity and respect. We also created educational curricula as well as initiatives that bring STEM learning to students and families alike.

In recognition of this work both inside and beyond the Museum's walls, we in 2022 traveled to Washington, D.C. to accept the nation's highest honor for museums, the National Medal for Museum and Library Service. (Which we were awarded in 2021... but were so excited to receive in-person this year!)

When I think back, I feel immense gratitude for the Museum family of members, donors and supporters. Your support has helped bring dynamic exhibitions and vital programs to life, creating moments of shared wonder and learning for more than 187,000 Museum visitors throughout the year. We couldn't do this work without you. As ever, thank you for supporting this amazing institution.




